Child Safeguarding Practice Review Panel: annual report 2023-24

The report reveals that 485 children were affected by serious child safeguarding incidents between April 2023 and March 2024. It highlights key themes and patterns in practice for national government and local safeguarding partners to improve the protection of vulnerable children.

The following themes emerged:

- Safeguarding children with mental health needs
- Safeguarding pre-school children with parents with mental health needs
- Safeguarding children from risks outside the family home

Spring Term 2025 Funding Information

Please ensure that you check funding codes are valid before offering any child a funded place.

Working entitlements

Parents need to apply to HMRC for a code, for either of the entitlements listed below, by **31 December 2024** if they wish to claim the 15 hours of funding for the spring term. We will not be able to use discretion to extend this deadline.

- 9month-old plus Working Parent Entitlement (WPE)
- Two-year-old Working Parent Entitlement (WPE)
- 30 Hours Extended Entitlement

Parents are expected to reconfirm their eligibility with HMRC every three months. If parents do not reconfirm their eligibility, then the funding will cease when the child reaches the end date of their grace period.

WPE and 30 hours Extended Entitlement codes can be checked on the Provider Portal using the existing Eligibility Checker.

Two Year Olds – Targeted Funding

To confirm eligibility, parents are expected to apply via Brighter Futures for Children's online <u>citizen</u> <u>portal.</u>

Please ask the parents of any targeted 2-year-old children to show you their confirmation email from us containing their eligibility code (it will be a 6-digit combination of letters or numbers). Brighter Futures for Children will only issue codes to children who are eligible.

If the child in your care has been issued with a targeted 2-year-old code from another local authority, please send us their details so that we can validate it for you.

Please note that targeted 2-year-old codes do not have 'start or end' dates, nor do they require reconfirmation.

ROUND 2 - Early Years (30 hour) Expansion Capital Funding

Any private, voluntary and independent providers delivering funded early years places, including maintained nursery schools, that would like to expand their 30-hour childcare offer are asked to complete a formal funding application **by 6pm, Friday 31 January 2025.**

Any Maintained Nursery Classes that are interested in expanding their nursery are directed to apply to the <u>school-based nurseries capital grant available to schools</u> by midday, on 19 December 2024.
