### Safeguarding

#### **EYFS changes 2025**

If you are starting to prepare for the <u>changes to EYFS legislation</u> due in September 2025, there is a page on the Foundation Years website that will help.

#### **Toy safety**

There is an interesting article in Nursery World around <u>buying 'dangerous' toys from low price</u> <u>overseas websites</u>. The CAPT has produced a toys fact sheet with advice on which toys are most dangerous for children and how to buy safe toys. Dangerous toys highlighted in the <u>fact</u> <u>sheet</u> include: Cheap copies of popular toys water beads – dangerous if swallowed. Magnetic toys, baby sleep products, slime - some can contain high doses of harmful chemicals.

#### Wider considerations

The Department for Education (DfE) has published a <u>policy statement</u> outlining the Government's commitment to reforming the children's social care system in England.

#### Leadership

#### **Level 3 SENCO Training**

This training programme, developed by School Improvement Liverpool, is for Early Years SENCos, or those due to take over the role, wanting to gain a qualification and recognition for their role as an early years SENCo. The course is accredited by NCFE CACHE, who are the leading awarding organisation for the care sector. Training days comprise of 12 guided learning sessions with time allowed for own research and writing of assignments.

The course takes place over 12 Friday sessions at the Civic Offices and all 12 sessions **must** be attended.

The cost of the training is £550pp and this must be paid before the course starts to secure your place. If you have any questions or would like to discuss alternative payment options to enable staff to attend the training please contact the team.

## **EYFS and Beyond**

#### **Ofsted update**

In November 2024, Ofsted completed their annual programme of Best Start in Life Curriculum Roadshows on the prime areas of learning, during which they continued to focus on the importance of communication and language and draw on the second part of their <u>early years research</u> <u>reports</u>. Following on from this, they want to make sure these events are as accessible as possible, especially to childminders. To help with this, they are delivering a live webinar specifically designed for childminders. The <u>webinar</u> takes place on 16 December from 7-8pm.

You will hear from Ofsted inspectors about:

- the importance of the prime areas of learning
- what a curriculum is for the prime areas
- how we look at the prime areas on inspection
- the top 10 takeaway points from our research

#### Where you can find out more

You can read Ofsted's completed <u>Best Start in Life research review</u>, and watch back a recorded version of the roadshows from last year, which explores <u>communication and language</u> on the Ofsted YouTube channel. It has produced some short videos on YouTube in a specific playlist called '<u>Early years FAQs for providers and practitioners</u>. It also address some commonly asked questions in the 'Ofsted inspections: what early years providers and practitioners need to know' collection.

#### **Department for Education update**

The Department for Education has published the **updated** <u>Early Years Foundation Stage (EYFS)</u> <u>Profile handbook</u> to support teachers and practitioners to complete EYFS Profile assessments in line with statutory requirements.

This update includes a change to allow a child's established or preferred mode of communication (including non-speaking communication, such as signing) to be used for all the early learning goals (ELGs), including the Speaking ELG.

To be judged as expected, children must demonstrate the criteria of the ELG. The mode of communication is the way a child chooses to communicate, not the language a child communicates in. Therefore, when using any mode of communication, the ELGs for the communication and language and literacy areas of learning must still be assessed in relation to the child's competency in English, or competency in British Sign Language.

#### **Embedding musicality in everyday provision**

In a publication for the Education Endowment Foundation's (EEF) Early Years hub, Professor Sara Baker considers how having fun with nursery rhymes can strengthen children's self-regulation What do nursery songs and self-regulation have in common?.

#### **National Literacy Trust**

National Literacy trust recently asked parents & carers of early years children aged from birth to 5, how often they were taking part in key learning activities with their child, including: reading, chatting, playing, singing, painting and drawing, playing outside, engaging in digital learning activities, visiting the library and group activities that support language development. Findings from the survey in summer 2024 were compared with results from surveys conducted in 2019, 2020 and 2021. Read <a href="here">here</a> for key findings from the research. #### **New ISP webinar**

We have added a PowerPoint presentation to guide practitioners through <u>writing an individual</u> <u>support plan</u> (ISP) for a child with additional needs. It includes an example plan and guidance on best practice. This can be used for information or as a support tool when writing ISPs.

#### **Breakfast Clubs Early Adopter Scheme**

Schools with primary-school-aged children can apply to become an early adopter of the universal free breakfast clubs scheme. The expression of interest form is now live and will close on the **20 December 2024**. The Department for Education will be introducing free breakfast clubs in up to 750 early adopter schools from April 2025 as part of a test and learn phase in advance of national roll out.

## Flexibility of provision

Did you know you can Register as a childminder without domestic premises - New application guidance for a new category of childcare provider - childminders who provide care solely from somewhere other than a home - as part of a series of changes the Department for Education (DfE) has introduced to give the early years sector more flexibility. Ofsted has begun accepting applications for this new type. It has published a blog post by Jayne Coward, Deputy Director for Early Years Regulatory Policy and Practice, and a series of videos explaining the changes and answering some questions that may arise:

- New changes for childminders and childcare on domestic premises providers
- What is a childminder without domestic premises?
- Further flexibility for childminders
- Working from non-domestic premises removing the 50% limit
- Updates for currently registered childcare on domestic premises providers
