## **Ofsted: Big Listen response**

Ofsted has published a detailed response to its 'Big Listen' consultation, setting out how the inspectorate will reset its relationship with the sectors it inspects and regulates, while continuing to raise standards for children and learners.

## **Ofsted: Inspection system**

Ofsted will no longer provide a single overall grade of effectiveness when inspecting state schools. State schools will still receive the existing sub-judgements across different areas of school life. Early years provision in maintained schools and academies for children aged 2 and above, and maintained nursery schools are included in this change.

The government is committed to replacing single headline grades in all the remits that Ofsted inspects in time, including the entirety of the early years sector. Until this change is made, all early years settings registered on the early years register, including childminders and private, voluntary and independent providers will continue to receive a single headline grade of overall effectiveness alongside the sub judgements.

The DfE and Ofsted will work in partnership with the sector over the next year to develop alternative inspection and regulation arrangements that maintain a strong focus on quality and standards, while responding to feedback on what needs to change. New arrangements will take account of the unique characteristics of the sector but will broadly reflect the report card approach that is being taken for schools.

## **EY Stronger Practice Hubs**

The Department for Education (DfE) has announced an extension to the Early Years Stronger Practice Hubs programme until at least March 2025. The programme supports nurseries and childminders by bringing groups together across local areas to share evidence-informed practice and advice, and build lasting local networks.

## **Domestic abuse**

The charity For Baby's Sake has published new data on infants and domestic abuse in England. The charity sent out a Freedom of Information request to 39 police forces and received responses from

15. The data indicates that infants were present at around 13% of police call outs for domestic abuse incidents from 2021 to 2023. The charity highlights a need for a coordinated, multi-sector response that safeguards babies and children from domestic abuse.
